

Purchase Contract for an English Cream Golden Retriever Puppy

1. Puppy Description

2. Purchase Price

The price of our puppies starts at \$1,000, but may be higher depending on the puppy's characteristics, breeding rights, and other factors as agreed upon by the Seller and Buyer.

If an additional delivery fee applies, it will be based on the distance and locations between the Breeder and the Buyer.

To reserve the puppy, a \$500 deposit is required by the Breeder. This deposit goes toward the total price, secures the Buyer's spot on the waitlist, and demonstrates commitment to the purchase, helping the Breeder prioritize serious buyers.

The deposit is fully refundable and transferable to a future litter if needed.

The remaining balance is due at the time of puppy pickup or delivery unless otherwise agreed upon in writing.

3. Health Guarantee and Veterinary Examination

The Breeder offers the following health guarantee:

Upon receiving the puppy, the Buyer has 72 hours to have it examined by a licensed veterinarian.

If the veterinarian discovers any health issues, disabilities, or critical conditions that cannot be resolved, the Buyer must provide the Breeder with the veterinarian's written findings within the 72-hour period.

If validated, the Buyer will receive a full refund of the purchase price.

For genetic or hereditary conditions appearing after the initial 72-hour exam, the health guarantee applies up to one year of age. If confirmed by a licensed veterinarian as

hereditary, the Breeder will work with the Buyer to provide options including partial or full refunds or assistance with rehoming.

The Breeder will cover any expenses incurred during the refund process.

Note: This guarantee does not cover minor health issues or illnesses that manifest after the 72-hour examination period.

4. Return Policy

If unforeseen circumstances prevent the Buyer from keeping the puppy, the Buyer agrees to return the puppy to the Breeder.

Upon return:

The Buyer will be reimbursed 50% of the original purchase price.

The puppy must be returned in good health and reasonably cared for.

Important: The puppy may not be sold or transferred to any third parties, shelters, or adoption agencies.

5. Buyer's Responsibilities

The Buyer agrees to:

Provide proper care, including appropriate food, water, shelter, and veterinary care.

Not sell, give away, or transfer ownership without prior written consent from the Breeder.

Follow all applicable local, state, and federal laws regarding pet ownership.

6. Breeder's Responsibilities

The Breeder agrees to:

Provide the puppy in good health, vaccinated, dewormed, and with initial veterinary examinations.

Provide all relevant documents such as registration papers, vaccination records, and health certificates.

7. Shipping Policy for Puppies

For puppy shipping, 50% of the total amount is required upfront. The remaining balance is due after delivery information is provided and confirmed.

The Buyer assumes full responsibility for the puppy's care during shipping, including managing any emergencies or health issues in transit.

If health issues arise that are deemed the Breeder's responsibility, and the puppy must be returned, the Breeder will cover the cost of return shipping and handle the shipping process at that time.

8. Limitation of Liability

The Breeder is not liable for any injury, damage, or health issues occurring after the 72-hour examination period, except as provided in this Contract.

9. Governing Law

This Contract shall be governed by the laws of the state in which the Breeder resides.
